InsurPac is one of the reasons why the Big I is routinely rated on the top-25 list of most successful lobbying groups in Washington D.C. By pooling individual contributions, InsurPac raised \$1.3 million in 2024 to help elect candidates and re-elect members of the U.S. Congress who share the Big I's business philosophy. While contributions do not buy solutions to legislative debates, they do allow the Big I significant 'face time' with very busy elected officials to give us an opportunity to educated them.

Here are some examples recent Big I/InsurPac victories:

- We defended the current tax rates for S-corps and C-corps, keeping the 20% small business tax deduction intact, and preventing an increase in the capital gains tax.
- We successfully lobbied against the Federal Housing Finance Agency, Fannie and Freddie to start scrutinizing home mortgages that don't carry full replacement-value insurance coverage
- We successfully secured an exemption for agents from reporting beneficial ownership to the Treasury Department's Financial Crimes Enforcement Network.
- We successfully advocated for the extension of the National Flood Insurance Program (NFIP).
